1.6 TECHNICAL DETAILS

The standard height of stand walls is 3,00 m; if exhibitors need to go higher than 3m, they have to send the project of the stand to the Responsible for Security Office: sate@promoberg.it and they must respect the rules in the Exhibitor Book, to be downloaded in the Bergamo Fair Web Area.

1.6.1 HALL "C"

Pavilion "C" is a temporary modular tent, the structure is made of anodized aluminum, the cover and the perimeter closure are made of white blackout curtains. The internal perimeter of the pavilion is fitted out with wooden walls white painted The pavilion's flooring is made of floating wood, and its maximum capacity is 600 kg/sqm. For this reason, it is not possible to access to this area with a forklift for moving heavy loads. The access gates to this structure have dimensions: 4.5 m wide x 3.5 m high.

- If a part of the system was built by another company (for example, ventilation and flue gas in gas systems), the declaration must contain similar references to the parties.
- 8) Example: Any certificates of the results of test performed on the first start-up or treatment for cleaning, disinfection, etc.
- 9) At the conclusion of the installation the company is required to issue the customer the declaration of conformity of equipment in accordance with the rules laid down in Article 7. The client or the owner is obliged to entrust the work of installation, conversion, expansion and maintenance of the facilities referred in article 1, and companies authorized within Article 3.
